

मेरठ में शादी के जश्न में चली गोली, युवती की मौत; आरोपी गिरफ्तार

घटना में प्रयुक्त तमचा बरामद, 20-25 अज्ञात व्यक्तियों पर मुकदमा दर्ज

मेरठ, 25 नवंबर (जनसत्ता)।

मेरठ जिले के लिसाड़ी गोली चलने से एक युवती की मौत हो गई। पुलिस के एक अधिकारी ने मंगलवार को बताया कि मामले में एक आरोपी को गिरफ्तार कर लिया गया है।

पुलिस के अनुसार मृत युवती की पहचान श्याम नगर निवासी अक्षया (22) के रूप में हुई है। अक्षया सोमवार देर रात कालोनी में हाजी शाहनवाज के बेटे सुहेल की बारत देख रही थी। पुलिस ने बताया कि इस दौरान कुछ लोगों ने जरार गोलियां चाली थीं और एक गोली छत पर खड़ी अक्षया के पेट में लग गई।

गंभीर रूप से घायल युवती को परिजन तुरंत बाग्यत रोड स्थित केपिसी अस्पताल ले गए, जहाँ उपचार के दौरान युवती मृत हो गई।

नागर पुलिस अधीक्षक (सिटी) आरुष विक्रम सिंह ने मंगलवार सुबह बताया कि घटना की सूचना मिलते ही पुलिस टीम मौके पर पहुंची। अपरपास लोगों से सीसीटीवी कैमरों की जांच में पता चला कि योगी साकिब नामक युवक ने चलाई थी। पुलिस ने देर रात ही साकिब को गिरफ्तार कर उसके कब्जे से घटना में प्रयुक्त तमचा बरामद कर लिया। अधिकारी ने बताया कि घटना के दौरान मौजूद अच्युत युवक मौके से फरार हो गए, जिनको तताश जारी है।
